He was also previously CEO of Anglo American's Zinc Business, leading the operational turnaround of the Lisheen and Black Mountain mines, and GM of Anglo American's nickel mine and smelter in Venezuela. John was also instrumental in the internationalisation of Anglo American's coal business, including the acquisition of the Colombian and Australian coal assets.
